The following information explains what may happen following an enquiry about the results and any subsequent appeal of an examination.

Exam boards can only correct genuine marking errors, they cannot change reasonable marks – OFQUAL 2016

If your examination centre makes an enquiry about the result and a subsequent appeal of one of your examinations after your subject grade has been issued, there are three possible outcomes:

- Your original mark is lowered, so your final grade may be lower than the original grade you received.
- Your original mark is confirmed as correct, and there is no change to your grade.
- Your original mark is raised, so your final grade may be higher than the original grade you received.

In order to proceed with the enquiry about results, you must sign the form below. This tells the head of your centre that you have understood what the outcome might be, and that you give your consent to the enquiry about results being made.

The exam boards offer the following Enquiry about Results services:

Service EAR1 (Clerical re-check) This is a re-check of all clerical procedures leading to the issue of a result.

Service EAR2 (Post-results review of marking) This is a post-results review of the original marking to ensure that the agreed mark scheme has been applied correctly. Includes a clerical-recheck. Available for externally assessed units.

Service EAR2P (Priority post-results review of marking) As service 2 but available for A Level candidate's whose place in higher education is dependent on the outcome.

PRIORITY PHOTOCOPY This service should be used to decide whether or not you should apply for a review of marking (GCE only unless Pearson). Not available with service 2P.

ORIGINAL SCRIPT This service should be used if you want to see your script, but do not want a review of marking.

If you request an Original Script you can **NOT** then request a review of marking. You can request a review of marking if you request a photocopied script.

Free*: Pearson's Free Access to Scripts Service – The ability to download from Pearsons the students exam scripts – **This service is available until the 14th December**
